Haemorrhoids are classified in four groups as per the presentation of pathology as follows, 1st degree - Anal cushions bleed, but no prolapse, 2nd degree - Anal cushions prolapse, but reduces spontaneously, 3rd degree - Anal cushions prolapse on straining but require manual replacement and 4th degree - Permanently prolapsed and irreducible. <sup>3</sup>

## **ETIOLOGY**

Hemorrhoids are the basically life style diseases. The following are the predisposing factors for the hemorrhoids such as chronic constipation, fiber-deficient diet, repeated infection of anal lining, straining at the time defectaion and porta hypertention.

## **CLINICAL FEATURE**

Clinical presentation of hemorrhoids mainly includes pain in anus, bleeding per rectum, pruritus ani, prolapse of rectum etc. all the complains generally increase at the time of defecation.

## **DIAGNOSIS**

Diagnosis of hemorrhoids is generally based on physical examination. Rectal digital examination, proctoscopy along with patients' disease history.

## **PROGNOSIS-**

Hemorrhoids belong to chronic and incurable category of diseases therefore in initial cases full recovery is possible. In advance pathological conditions it becomes difficult to manage only with medicines. But if the hemorrhoids are managed along with life style correction, diet correction and roper treatment then the prognosis of disease is promising.
